Where to Use

FOR OUTDOOR USE ONLY. Apply only where no vegetation is desired, such as driveways, landscaped areas, around well-established (at least 6 months old) plants, trees and shrubs, along fences, sidewalks, walkways, patios, curbs, gutters and even cracks in sidewalks. DO NOT USE IN VEGETABLE GARDENS. DO NOT APPLY THROUGH ANY TYPE OF IRRIGATION SYSTEM. AERIAL APPLICA-TION IS PROHIBITED.

When to Apply

Apply to actively growing weeds and grasses. Visible effects should occur within 3 to 5 days with complete kill in 2 to 4 weeks. If rainfall occurs within 6 hours, repeat treatment may be required. To avoid drift to desirable plants, apply only when air is calm. If leaves of desirable plants are accidentally sprayed, immediately wash off plants with water. Spray when air is calm to prevent drift to desirable plants. For best results, apply during warn, sunny weather (above 60°F).

How to Apply/Use

- 1. Turn sprayer nozzle to open. Adjust sprayer nozzle as desired.
- Spray to thoroughly cover unwanted weeds and grasses or spray to thoroughly cover areas where you want to prevent weed and grass growth.
- 3. Do not spray plants or grasses, as damage can occur.
- When treating around desirable plants, shield plants from drift with a sheet of cardboard or plastic. If desirable plants are accidentally sprayed, rinse off immediately with water.

When to Replant

All ornamental bedding plants, trees, shrubs, sod and seed (flowers and grasses) may be planted 6 months after application when applying at the 24 fl. oz. per 450 sq. ft. rate or 12 months when applying at the 24 fl. oz. per 255 sq. ft. use rate.

STORAGE AND DISPOSAL
