DIRECTIONS FOR USE

Shake well before each use, granules are naturally moist and may clump. Lightly sprinkle granules in and around areas you want to protect.

Note: Can be applied directly onto plants. NOT FOR USE ON FOOD CROPS.

PROBLEM	*INITIAL APPLICATION PERIOD	MAINTENANCE
Average	2 times per week for 2 weeks	1 time per week
Severe	3 times per week for 3 weeks	1 time per week

*Must be applied as directed. Allow 2 to 3 weeks for product to take full effect.

Apply at a rate of 1oz. of product per 50 sq. ft. This bag will cover up to 2,600 sq. ft.

Perimeter/Barrier Treatment: Sprinkle a band 6-8" wide around the area you want to protect.

Burrowing & Tunneling Animals: Sprinkle granules into all holes and tunnels.
